MEETING OF THE SUNNYSIDE DIVISION BOARD OF CONTROL

The regular meeting of the Sunnyside Division Board of Control (SDBOC) was held in-person and via conference call, and was called to order by Chairman Simpson on June 3, 2025, at 1:30 PM. Present in addition to Chairman Simpson was Director Paul Groeneweg, Dave Michels, Mike Hogue, and Kevin Golob; David Felman, SDBOC Secretary/Treasurer, Ron Cowin, Assistant Manager- Engineering, Dave Bos, Assistant Manager-Operations, Nikki Musson, SDBOC Deputy Treasurer/Office Manager, and Norman Semanko, Legal Counsel for the Sunnyside Division Board of Control. Also in attendance was Markus Rollinger, landowner. Justin Bezold with Trout Unlimited participated via phone.

The minutes of the May 6, 2025, Board Meeting were reviewed. Upon a motion by Director Golob, that was seconded and unanimously carried, the minutes were approved.

The Board reviewed the vouchers numbered 6543-6557 in the total amount of \$157,380.04 which were submitted for approval. A motion was made by Director Michels which was seconded and unanimously carried, authorizing payment of the vouchers as listed above.

Mr. Bos presented the water supply report. As of June 3, 2025, storage in the mountain reservoirs is at 707,698 acre-feet or 66% of capacity. Storage content is 73.9% of average. Precipitation for the year to date (Oct 1 to June 3) is 163.73 inches or 79% of average. Snow pack is no longer being reported. SVID is diverting 920 cfs. The current pro-rationing amount set by the Bureau of Reclamation is 48% and the Yakima Basin went on pro-rationing on May 20th. Storage control has yet to be set. The next River Ops meeting is scheduled for June 5th, 2025.

Mr. Cowin presented the ELIPS Material bid. Four bids were received by Ferguson - Pasco, Core & Main – Pasco, HD Fowler – Yakima, and Orchard and Vineyard Supply - Pasco. The low bid for Schedule A was submitted by Ferguson in the amount of \$545,804.60. The low bids for Schedules B, D, and E were submitted by HD Fowler in the total amount of \$497,120.91. The low bid for Schedule C was submitted by Orchard and Vineyard Supply in the amount of \$190,474.41. A motion was made by Director Groeneweg which was seconded and unanimously carried, authorizing the award of the bid schedules listed above. The bid summary is attached and by this reference incorporated into these minutes.

Mr. Felman informed the Board that the Division had been approached by Reclamation regarding the potential absorption of the Buena Irrigation District. Due to costly repairs required for its existing river diversion and fish screens, the Buena Irrigation District is exploring the feasibility of obtaining water from the Sunnyside Canal. Discussions with Reclamation are ongoing.

There being no further business, the meeting was adjourned at 1:49 PM.
