Payment must be made at the time of sale and must be by cash, bank cashier's check, or negotiable instrument of equivalent security. In addition to payment of the purchase price, Purchasers must pay the full amount of any an all property taxes, drainage or diking district assessments, drainage or diking district improvement assessments, irrigation district assessments due at time of sale, together with costs and interests relating to such taxes or assessments, prior to receiving a Treasurer's Deed to the property.
